## The Secure Way to Mark Rooms in a Building as Safe or Unsafe During an Emergency

CodeX allows administration to set up groups of phones. Those groups can then be selected if an emergency arises, and a CodeX can be initiated. This will broadcast a prerecorded message to the selected groups. Upon hearing the announcement, a pin code must be entered within a limited time, either marking the room safe, unsafe, or unreported. Codex then displays the list of rooms and their status. This can be critical information for first responders. With the addition of the Clearly Anywhere mobile softphone, a CodeX can be initiated or responded to using a cell phone from any location.

### Why Do Organizations Need CodeX?

With CodeX you have one more tool to help ensure you are prepared when an emergency happens.



#### Mark Areas as Safe During an Emergency

Quickly and easily records safe or unsafe responses and displays the information in a color-coded format.



#### Auto Logs Incoming Responses

A date and timestamp are logged for each response. This can be valuable for establishing timelines during an emergency.



#### Verified Location Reports

Reports are recorded for each room, allowing responders to see the rooms they need to be concerned with quickly.



#### Individual Room Reporting

Announcements can be sent out in call groups or to the entire building. Regardless of the way the announcement is sent, each individual room will have a report designation.



#### Manages Emergency Announcements

During an emergency the last thing you want to cause is panic. By prerecording the announcements, the administrator can choose which announcement to send and not worry about how it sounds.



#### Offers Options for Responses

Rooms can be marked as safe, unsafe, or unreported. ClearlyIP offers tools that integrate with CodeX to allow further clarification on room status.

# What Organizations Would Benefit From CodeX?



## Education K-12

CodeX can send out the administrative announcement to the entire school or send different messages to pre-selected groups. The response time can be set by authorized users and when classrooms respond with a short code for Safe or Unsafe. Rooms that do not report in the allotted time are marked in yellow and can be further investigated by administration.



## Colleges and Universities

College campuses often cover acres of land and contain multiple buildings. CodeX allows Public Safety to set up announcements for separate buildings and record the responses so that the information is available to first responders and administration. If there was a gas leak in one building, the occupants can be alerted quickly.



## Courthouses

Courthouses can contain upwards of 20+ individual courtrooms. The building administrator can set call groups by room, floor or whatever designation makes sense. These groups can then all be alerted at once to an emergency. The response calls are all logged with date and time. Sometimes situations escalate quickly, and minutes can make a difference.



## Municipalities

Large buildings with many different departments. CodeX allows for a fast, organized and reliable way to notify room or building occupants of an emergency and let them respond with their current safety level. This information is invaluable to first responders, allowing to see the current situation and evaluate accordingly.
